Summary of the Filing:

- Verify with the Clerk that the documents filed with the Clerk; are all in the court record; and that there aren't any documents missing.
- Inform the Clerk that Clive and Lara are still negotiating the issues in dispute; and that further documents may be filed; by either you or me; to provide each other with answers; or ask each other questions; or provide evidence for any answer we gave or statement we made; or to subpoena any other person; if such person can provide information to help us to resolve the issues in dispute. Here are the excerpted paragraphs:

----- Excerpt: Letter to Clerk of Court -----

19 April 2016 Negotiations of Issues in Dispute:

Later during proceedings when Magistrate Essel focused on the issues in dispute between Clive and Lara; Magistrate Essel asked whether Lara and Clive had managed to resolve their negotiations and issues and dispute and come to an agreement.

Lara said not yet; but she was hoping that was possible; so that they could come to an agreement and either withdraw the application; or present the court with their final agreement. However Lara understood that the issues in dispute; were not minor issues; that she had been confronting these issues for a long time; and understood that Clive was experiencing difficulty in confronting these issues.

Magistrate Essel said that in the meantime he would need to read the paperwork that had been filed; so that he could know better what it was all about.

Magistrate Essel postponed the matter to 10 May 2016; for (i) Lara and Clive's further negotiations; and (ii) Magistrate Essels' reading of the court filed documentation; including Lara's Reply Affidavit; to see what further information Lara had requested from Clive.

Re: *Lara and Clive's further negotiations:*

Clive and/or Lara may choose to file further:

- Response Affidavits: to clarify any of their statements; ask questions; or provide answers; and/or
- Amended Notice of Motion: to clarify and summarize any issues in dispute; and/or which could include other respondents to help Clive, Lara and the Court; to clarify any particular issue of dispute; and/or
- Suspend and postpone the case; for Clive to have time to decide whether he wants to resolve these proceedings via court proceedings; and/or
- Decide to agree to disagree regarding any one or more of the issues in dispute; and withdraw that issue in dispute; as an issue in dispute.

----- End Excerpt: Letter to Clerk of Court -----
