**Reply Affidavit of Lara Johnstone**

---

I the undersigned,

LARA JOHNSTONE

do hereby make oath and say:

[1] I am the biological daughter of Clive Henry Johnstone and Ann Elizabeth nee Bosman; born in Volksrust, Transvaal; Apartheid South Africa; on 04 December 1966.

[1.1] Clive Henry Johnstone was born to John “Jack” Henry Johnstone and Charlotte Thom, in Volksrust, Transvaal; Apartheid South Africa; on 28 October 1935.

[1.2] Ann Elizabeth Bosman was born to Andries Willem “Toy” Bosman and Elizabeth Gertruida Kolver, in Standerton, Apartheid South Africa; on 14 February 1946.

[2] The facts set out herein fall within my personal knowledge, unless otherwise indicated by the context, and are to the best of my subjective knowledge true and correct.

[3] At times in this affidavit; I refer to myself as I; and at other times; for ease of understanding as Lara. If or when I am informed of, or become aware of any evidentiary information in this affidavit that is proven incorrect; I have no problem

providing the court with my apology for informing the court of information subjectively considered to be accurate; but subsequently proven to be incorrect. Until such time; to the best of my subjective knowledge the following information is true and correct.

**Summary of Lara's response to Clive 13 April 2016 Notice to Oppose:**

[4] Lara suggests that the matter be postponed to provide Clive the opportunity to digest the evidentiary contents of Lara's Response Affidavit; for his further consideration; to provide the court with his responses to Lara's questions and suggestions to the Issues in dispute.

[4.1] *Assisted Suicide*: Considering the contradictory representations between Clive's 08 November 2015 and 13 April 2016; responses to Lara's assisted suicide request; should Lara and the court interpret Clive's 13 April 'solution' as an offer for further negotiation; or as a fully informed final decision?

[4.2] *Taaibos Barter Agreement*: Pending resolution of Dignitas Assisted Suicide – whether financed by Clive; or by Dignitas via Exemption of Fees – which can take months and sometimes a year or two to get required paperwork approved; Lara suggests Lara, Clive and Ann take this opportunity to draw up a temporary Taaibos Residency Rules Agreement.

[4.3] *Mental Disorder Allegations*: Lara's hypothesis is that there are numerous factors that collectively contribute to the reality that it is understandable that Clive may have doubts about what to believe regarding Lara's state of mind and activities. Consequently Lara has some suggestions for Clive and the court to consider; to enable Clive to make a more fully informed decision about whether he wants to make 'mental disorder' allegations against Lara.

[4.4] *Timothy McVeigh Faked Execution*: Lara has informed Clive that there were possible signals intelligence clues; that could be interpreted as a message that Timothy McVeigh; or if not Timothy McVeigh; someone pretending to be Timothy McVeigh; used military intelligence psychotronic technology to partially cause Clive's GI bleeding attack.

[4.5] *Get a Job or Prove EoP Activism is Worth It*: Is Ecology of Peace Activism worth it? If there are any individuals on planet earth who prefer a relatively orderly, humane and fair de-industrialization and depopulation process; for themselves and their families; the honest answer would be: Yes, it's worth it. If none. No.

[4.6] Responses to other Facts in Dispute and/or Cultural Interpretation &/or Communication Policy Differences: *Responsible Procreation and Existence of God*.

**Clive Johnstone Affidavit dated 13 April 2016:**

[5] On the evening of 12 April 2016; before attending his bible study; Clive Johnstone provided me with a hand written affidavit. I asked if he wanted me to type it. He said yes.

[6] I typed it exactly as he had written it.

[7] At 7:44 PM; I emailed Clive the typed version in document format for him to edit; if he wanted to. I also informed him that I had a different perspective or interpretation of various events he refers to in his affidavit; and also noticed a few of what I culturally consider errors of fact. I suggested two options: I could either provide him with my perspective and facts; and he could consider my evidence and edit his affidavit; and then submit it to the court; or he could submit it to the court; and I could provide my perspective and facts to the court. He opted for the second option. [A.25<sup>1</sup>]

**Facts Not in Dispute; Facts in Dispute and/or Different Interpretations of Events and/or different cultural communication policies:**

[8] *Possibly Relevant:* The applicant has different perspectives; including possible facts in dispute, and/or different interpretation of events and/or different cultural communication policies; with regard to whole sentences, phrases within sentences or words within sentences in Clives Affidavit: paragraphs 1 – 37.

[9] *Agree to Disagree:* The applicant is however focussed on attempting to resolve what appears to her to be the main issues in dispute; in as focussed and timely manner possible; and is consequently willing to consider other disagreements of perspective or facts under ‘agree to disagree’; unless it subsequently appears any one or more of those un-referred to agree to disagree issues; are contributory causes or relevant to the primary issues in dispute; and require further evidentiary deconstructing for the court to consider in its deliberations.

[10] This Reply Affidavit consequently focuses on the possibly relevant Facts in Dispute and/or Different Interpretations of Events; and/or Different Cultural Communication Policies; ignoring the remaining Agree to Disagree issues.

[11] ***Facts Not in Dispute:***

[11.1] P.1: Clive is the biological father of Lara Johnstone.

[11.2] P.23-25: Lara has received financial assistance from Clive.

[11.3] P.33: Lara has also on numerous occasions let Clive and Ann know that Lara didn't request to be born.

[12] ***Financial / Labour Assistance Facts in Dispute:***

[12.1] P.23-25: Lara has received financial assistance from Clive; partially reciprocated with labour assistance from Lara [A.26<sup>2</sup>].

**Assisted suicide 'solution' offer: Amend Clive and Ann's Will's:**

[13] Clive Assisted Suicide Response:

[13.1] Paragraph 31: Lara is of the opinion that once her biological parents have passed on, that some of her remaining family will try to have her put in an institution for people suffering 'mental disorder'.

[13.2] Paragraph 32: To avoid this, she would rather depart the planet as she puts it via Dignitas Assisted Suicide in Switzerland, or something similar in Russia if she fails to be united with Timothy McVeigh.

[13.3] Paragraph 36: 'My only solution to Lara's [Dignitas Assisted Suicide] request is to stipulate in [Clive and Ann's] Wills that [Lara] be able to use her portion of her inheritance to fund her 'departure from this planet'.

**Lara request for clarity re: Clive assisted suicide 'solution' offer:**

[14] Considering the contradictory representations between Clive's 08 November 2015 and 13 April 2016; responses to Lara's assisted suicide request; should Lara and the court interpret Clive's 13 April 'solution' as an offer for further negotiation; or as a fully informed final decision??

[14.1] ***On 08 November 2015 Clive informed Lara of his demands:***

- A. Clive is no longer interested in any barter exchange agreement with Lara for Lara's continued residence at Taaibos Ave.
- B. Clive is willing to provide Lara with the funds requested to travel to Russia or Switzerland; to arrange her assisted suicide departure from planet earth. Lara should get the details so that the assisted suicide information can be provided to Clive so that Clive can provide the funds

for Lara to make the arrangements for her Swiss or Russian assisted suicide. [A. 03, 05, 15<sup>3</sup>]

[14.2] ***On 13 April 2016 Clive informed the court of his ‘Solution’ Offer:***

- A. Clive’s only solution to Lara’s Dignitas Assisted Suicide request is to amend Clive and Ann’s wills; to state that Lara may be able to use her portion of her inheritance to fund her ‘departure from this planet’.

[15] If Offer for Negotiation: What information may be useful for Clive to be able to make a fully informed final decision; so that Lara can see if she is able to help to acquire that information?

[16] If Final Fully Informed Decision: Does Clive’s decision exclude Clive willingness to help Lara to write a letter to confirm various financial related matters; for her to make a submission to Dignitas for Exemption of Fees? [A. 21, 22, 23, 27<sup>4</sup>]

**Temporary Taaibos Barter Exchange Agreement:**

[17] Pending resolution of Dignitas Assisted Suicide – whether financed by Clive; or by Dignitas via Exemption of Fees – which can take months and sometimes a year or two to get all the required paperwork; Lara suggests Lara, Clive and Ann take this opportunity to draw up a temporary Taaibos Residency Rules Agreement.

[18] The initial Taaibos Barter Exchange Agreement included among others the following issues in dispute: ‘Taaibos Residency Rules’; ‘Assisted Suicide’; ‘Mental Disorder’ allegations; ‘McVeigh Faked Execution’; ‘Get a Job or prove that your Ecology of Peace Activism is worth it’. [B: 01, 02, 03, 04<sup>5</sup>]

[18.1] ***Taaibos Residency Rules:***

[18.2] Can Clive or Ann clarify their temporary Taaibos Barter Exchange Agreement residency rules?

- A. Such as related to chores, emailing; or any temporary preference of Clive or Ann; to enable harmonious co-existence.

[18.3] *Lara Temporary Experiment Communication Policy Agreement Suggestion:*

- A. Anyone living in Taaibos house; who is angry with anyone else; can call a 'Ranting Letting off steam meeting'. At the Ranting Letting Off steam meeting; anyone can express themselves loudly and possibly offensively; and rant and let off steam. Statements said during ranting letting off steam meetings are to be interpreted as exactly that; and not to be taken personally; unless later confirmed in a problem solving meeting in less emotional terms. Once everyone has ranted and let off verbal steam; they can end the meeting; and take some time to reflect upon their ranting.
- B. A day or two later they can call a problem solving meeting; where they can calmly discuss whatever is still bothering them more calmly; while actively listening to each other's concerns; to see what the best options are for resolving whatever made the person angry. Hopefully this will enable decision-making that is not based upon emotional egoistic anger; but listening and cooperative problem solving.

[19] We have two options:

[19.1] We can start from where we sincerely are at; and we cooperate with each other by sharing honestly our preferences; our interpretations of reality; we eventually can and will come to some agreement; through a cooperative process; and our relationship shall benefit from the cooperative truthseeking win-win process.

[19.2] We can hide what we want; or who we are; or what we believe; or demand that one of us hide aspects of themselves so as to make others feel more comfortable; and start from where we think we are 'right' and the other is 'wrong'; we shall confuse ourselves; and each other; in a fight for who is the most right; politically correct; and who shall win the zero-sum slamdunk game; one shall be the winner with their boot on the loser; after they have conquered and dominated the other. Our relationship shall suffer and degenerate into a relationship of domination, propaganda and control instead of cooperation, honesty and solidarity.

**Lara request for clarity re: Clive Mental Disorder Allegations:**

[20] *Clive Affidavit: Possible 'Lentegeur Observation' Facts in Dispute:*

[20.1] P.15: Lara was illegally and irregularly twice sent to Lentegeur for observation. The High Court Registrar appointed Braam Swart and Partners as In Forma Pauperis Counsel; to investigate Lara's illegal and irregular malicious

arrest, admittance and detention in Lentegeur. Braam Swart and Partners declined to proceed; because they said it would be Lara's word against Magistrate Fortuin, Prosecutor Redelinghuys, JJ Marx, Sipoyo, Dr. Rausch and Legal Aid Attorney Anton Marx; Inspect Potje; none of whom would voluntarily take responsibility for their irregular and illegal actions against Lara . [C.01 & 02<sup>6</sup>]

[21] *Clive 06 April 2016 Verbal Meeting 'Mental Disorder' Statements:*

[22] Re: (i) Verbal Statements made by Clive Johnstone to Ann and Lara Johnstone on 06 April 2016; that Clive thought Lara had a 'mental disorder'; (ii) Written statements by Clive to Lara; confirming that he meant what he said in the 06 April 2016 meeting; but declined to confirm what exactly he had said that he meant; or whether he meant all of what he had said; or only some of it; and if what he had meant included his 'mental disorder' allegations [A.19, 20<sup>7</sup>].

[23] Lara's hypothesis is that as a result of (a) Clive not knowing much about psychology; particularly being ignorant about the fact that mainstream psychology and 'mental disorders' are based upon cultural conformity or non-conformity; rather than scientific mental illness; and (b) the result of so many family individuals – all of whom also know very little or nothing about psychology – jumping on the Lentegeur Prosecutor's Office bandwagon; informing Clive about their mental disorder allegations against Lara; thereby placing a significant amount of peer pressure on Clive to conform and agree with them about Lara's 'mental disorder' allegations; (c) Lara's involvement in non-mainstream activities that some people consider weird; (d) Clive understandably has doubts about what to believe regarding Lara's state of mind and activities.

[24] Consequently Lara has the following suggestions for Clive and the court to consider; to enable Clive to make a more fully informed decision about whether he wants to make 'mental disorder' allegations against Lara:

[24.1] Clive write a letter to everyone who has informed him that 'Lara has a mental disorder'; or whatever it was that they said that he interpreted as them implying that Lara has a mental disorder. Ask them if they are willing to put their verbal statements to Clive; in writing; which Clive can submit to Lara and the court; for Lara and the court's consideration and response.

[24.3] If Clive wants to; he can show the documentaries to any psychologist he chooses and get their feedback; as to the documentaries 'mental disorder parasitic profiteering and deception' allegations authenticity.

[25] Once Clive has received the (a) written responses of individuals who made verbal 'mental disorder' allegations to Clive against Lara; and Lara's responses to those allegations; /or (b) watched some of the aforementioned documentaries; and/or (c) discussed them with a psychologist; or any individual whose opinion he trusts; Clive can make a more fully informed decision on whether he wants to withdraw and apologize or confirm and stand by his 'mental disorder' allegations.

[26] If Clive chooses to:

[26.1] Withdraw and apologize for his 'mental disorder' statements; Lara shall accept his apology and withdrawal; and consider them as if they were temporary angry verbal ranting; made during a 'Letting Off Steam' meeting; and again suggest Clive and Ann consider Lara's aforementioned *Temporary Experiment Communication Policy Agreement Suggestion*; about how we can let off steam and release anger; before making decisions; about whatever may have made us angry.

[26.2] Confirm and Stand by his mental disorder allegations as Sincerely Legally Meant; Lara shall request permission from the court to file an Amended Notice of Motion; as follows:

- A. To order Clive to inform Lara and the court of his 'mental disorder' legal definition and evidence in support thereof.
- B. If Clive's Mental Disorder Allegations are proven to be (i) insufficient and/or unreasonable; (ii) not scientifically based; and/or consequently not universally applicable to persons from all races, classes, cultures or religions; including members of the Radical Honoursty Ecology of Peace culture; (iii) negligent or maliciously motivated; (iv) an order for damages between R10,000 to R200,000; depending on proven level of negligence or malice; for defaming the psychological integrity of Lara Johnstone; (vi) an order of referral of the case to the High Court; if the Magistrate considers the damages to be in excess of R 200,000.

### **Timothy McVeigh's Faked Execution:**

[27] *Clive Affidavit:*

[27.1] P.27 Lara claims that Timothy McVeigh exists and that they even have a relationship by email.

[27.2] P.28: Clive has never received any contact from Timothy McVeigh; so Clive can't vouch for the sincerity of the 'relationship'.

[28] Excerpt from Lara's *Founding Affidavit In support of Amended Notice of Motion 01: Issues in Dispute: McVeigh Faked Execution & Russia Assisted Suicide* [19]:

Responses to McVeigh Faked Execution Information:

Clive and Ann Johnstone:

Sometime in 2002: Clive and Ann Johnstone doubted the information about Timothy McVeigh being alive. So I suggested that they pick up the phone and call the White House. Ann Johnstone then called the White House; with the telephone number I had given her. She asked the White House person who answered the phone; if the people in the White House knew who I was. The man – name unknown or I can't remember – said yes the White House knew who I was; and asked Ann if she knew who my boyfriend was. Ann Johnstone replied: Timothy McVeigh; and the man and Ann then had a short conversation about Lara Johnstone and Timothy McVeigh.

[29] As noted in correspondence to FSB, NSA & MWeb [D.03: 20] and Karen Marshall [A.15<sup>21</sup>]; a final draft version of the aforementioned Amended Notice of Motion subsequently disappeared from my computer.

[30] Lara has informed Clive and Ann – and many other people – that Michael Martin informed Lara of the information that Timothy McVeigh's execution was faked; and that Michael Martin's information was confirmed for Lara by Steve West in the office of California Governor Gray Davis. [A.08<sup>22</sup>]

[30.1] Lara has confirmed that she has emailed an individual who calls himself 'Timothy Truthseeker' using the email -- truthseeker2436577@yahoo.com -- whom Lara has given the benefit of the doubt; that his cryptic messages that he is Timothy McVeigh are honest and accurate; and that he is Timothy McVeigh. Lara has never claimed that those email messages constitute a mainstream conventional 'relationship' between Lara and Timothy.

[30.2] Lara has among others (i) requested US Navy Judge Advocate General: Nanette Derenzi to order a JAG investigator to visit the home of the individual using the Timothy Truthseeker email address; to confirm whether he is or is not Timothy McVeigh; (ii) notified Ft Meade military commander of the possibility that Timothy McVeigh is employed on their Anne Arundel Co: Ft Meade military base facility; and of Lara's request for information from Timothy McVeigh [PDF<sup>23</sup>].

### ***EoP ICC Private Prosecution:***

The purpose of the EoP private prosecution complaint to the International Criminal Court – if or when filed – shall be to implement an Ecology of Peace international law social contract; that requires all the world's citizens to procreate and consume below ecological carrying capacity limits. On behalf of the EoP Applicants I have been preparing documentation for an ICC private prosecution in terms of Rendulic Rule Military Necessity doctrine; CA, UK, US & RSA Common Law Private Prosecution doctrine; Rome Statute: Art.5, 6, 7, 8 & 15; ICC Code of Judicial Ethics: Art 4, 5(1), 7 & 11. Charges: Crimes of Aggression Acts of War.

The Ecology of Peace culture's definition of 'crimes of aggression acts of war' is as follows: "Any individual who is found guilty of advocating on behalf of, legislating, enforcing, or obeying any – cultural, religious, common, statutory, constitutional, or international – 'scarcity combatant' social contract; which enables or advocates on behalf of human procreation, consumption or production of resources that transgress ecological carrying capacity limits, is guilty of the 'crime of aggression act of war'."

### ***Carrying Capacity Sustainability: I=PAT Equation:***

For activities to be genuinely sustainable it must be possible for them to continue indefinitely. The impact of humanity on the environment and the demands that people place on the resources available on the planet can be summarized by what is known as the Ehrlich or IPAT equation,  $I=PAT$ . I = impact on the environment or demand for resources, P = population size, A = affluence and T = technology. The two most important conclusions deriving from this IPAT footprint relationship are that: (i) the Earth can support only a limited number of people, at a certain level of affluence, in a sustainable manner; and (ii) Population and Consumption must be reduced to below carrying capacity.

An individual's IPAT footprint is a result of: (A) Consumption Footprint multiplied by (B) Procreation Factor.

**Consumption Footprint:** Consumption footprint calculators are based upon [Global Footprint Application Standards](#)<sup>47</sup>, and calculate an individual's consumption footprint based upon various questions about their consumption lifestyle's; and provide a final consumption footprint in global hectares which is the individual's 'consumption footprint'; i.e. the amount of global productive land required for the production of products the individual consumes. Consumption Footprint calculators can be found at among others: [Global Footprint Network](#)<sup>48</sup>; [Earth Day](#)<sup>49</sup>; [Center for Sustainable Economy](#)<sup>50</sup>; [EcoCampus](#)<sup>51</sup>.

Global Footprint concepts were developed by among others: Dr. Mathis Wackernagel; Dr. William Rees; Dr. Herman Daly and the Global Footprint Network Standards Committee is one of two committees overseeing scientific review procedures and standards for Footprint calculations.

**Procreation Factor:** According to the research of [Paul Murtaugh](#)<sup>52</sup>: A parent increases their consumption footprint by a factor of 20 for every child procreated.

**Carrying Capacity aka Biocapacity Limits:** "The maximum number of individuals that can be supported sustainably by a given environment is known as its 'carrying capacity'. Worldwide the total amount of biologically productive land and sea amounts to 12 billion global hectares (gha); or 1.8 gha each if divided by 6.7 billion each. Guerry's Laws are drawn up in accordance with the proactive conservation policies of Bhutan, who set aside 40% of their biologically productive to be returned to its natural state, for other species and wildlife conservation purposes; then that means that the total amount of biologically productive carrying capacity land available to humans is 60% of 12 billion; which amounts to 7.2 billion gha total; or 60% of 1.8 gha, which is 1 gha each.

Population factor is relevant, because the more humans there are, the less biologically productive land there is for everyone else.

For example:

**Biocapacity limits of 6.7, 3.5, 1 Billion, 500, 250 & 100 Million humans:** 7.2 billion global hectares of biologically productive land and water divided by (a) 6.7 billion humans, equals: 1.07 gha each; (b) 3.5 billion equals 2.05 gha each; (c) 1 billion equals 7.2 gha each; (d) 500 million equals 14.4 gha each; (e) 250 million equals 28.8 gha; (f) 100 million equals 72 gha each.

### **[35] *Clive Affidavit on Procreation / Conception & Existence of God:***

- A. P.1: My wife Ann and I were blessed with four healthy children, daughter Lara, son Graeme, daughter Wendy and son Andre.
- B. P.34: I am convinced that only GOD can give life.
- C. P.35: I refer to the God of Abraham, Isaac and Jacob, also known as Elohim, Adonai, Hashem or Yaweh.
- D. P.37: My wife's suggestion is: "My suggestion to Lara is that if she wants to take someone to court, she must take God to court seeing he gave her life."

### **[36] *Lara: Re: Responsible Procreation:***

- A. Lara, Graeme, Wendy and Andre are the biological consequence of Ann and Clive engaging in possibly irresponsible<sup>53</sup> consensual heterosexual vaginal sexual intercourse<sup>54</sup>; for sexual pleasure, reproduction<sup>55</sup> or both; by consciously<sup>56</sup> or unconsciously choosing not to use contraception<sup>57</sup> to prohibit conception<sup>58</sup> and subsequent pregnancy<sup>59</sup>.

- B. There is a difference between stating: (a) I take responsibility for the reality that I was young, naïve and unaware and simply procreated children; cause that is what everyone did; so I thought it was what I was supposed to do; and I support you educating others so that everyone can make more responsible family planning procreation choices; and (b) I was young, naïve and simply procreated children; and instead of taking responsibility for my procreation choices; I blame the consequences of my procreation choices; as being a result of God's decision to give life.

[37] ***Lara: Re: Existence of God:***

[37.1] *God as Omnipotent Being Creator of Universe:*

[37.2] Lara does not know whether God exists or not. In order for Lara to take God – or Allah, Buddha, Satan; etc -- to court; she would have to take the individuals who (a) state that God / Allah / Satan exists; and (b) that they are the earthly spokespersons of God / Allah' / Buddha / Satan; to court. If so; it would be upto those individuals to prove to the court that (a) God exists; and (b) they are God's spokesperson to accurately convey to other humans God's law, orders and/or messages.

[37.3] Lara's views on the origins of religions are detailed in her letter to Unashamedly Ethical: *Are Family Policy Institute and Unashamedly Ethical social and resource conflict problem solving ethics founded upon (i) Ecology of Peace factual reality or (ii) Masonic War is Peace flat earth beliefs?*; under the heading: *Working Hypothesis Summary: Origin of Man's Belief in God & Devil* [B.04<sup>60</sup>]

[37.4] Lara does not care whether anyone worships God, Allah, Buddha, Satan, their ancestors, the spaghetti monster; or their own ego; Lara has simply observed that:

- A. Presumably if God (a) exists; and (b) created the Earth; s/he would know that:
1. the Earth s/he made is not flat; and the resources are finite;
  2. Breeding and/or Consuming above ecological carrying capacity limits causes Overpopulation and overconsumption which results in social and resource conflict.
- B. If God further was a God of Peace; or thought some of his children may be interested in being members of religions of peace; s/he would:
1. Order his/her prophets / spokespersons to order his/her children to confront Ecology of Peace Reality Facts: (a) the Earth s/he made is not

*Beauty & Problem Solving Cooperation Theories:*

In *A Beautiful Mind* and *A Brilliant Madness*; the Nash Equilibrium theory is described as a mathematical principle of cooperation. of buildings; who may think that gravity does not exist and is not applicable to them because they are Muslims or gay or rich. Their collision with earth will prove gravity does exist; and Allah has not granted them any exemptions from ignoring gravity reality's consequences.

[42.5] Aforementioned 'Rahab & Joshua' or 'Nelson Mandela & Hendrik Verwoerd' EoP discussions are religious and political versions of EoP responses to -- with the exception of Lara's Justice Quartus de Wet & Jury Percy Yutar mercy' guarantee [E.01<sup>73</sup>] caveat -- soldier/spy Joshua's irrespective of whether their primary tribal identity was racial: African, European; religious: Christian, Muslim, Buddhist, Satanist; or ideological: Communist or Capitalist.

[44] Will the Ecology of Peace applicants succeed in implementing an Ecology of Peace international law social contract to restrict all the worlds citizens to procreating and consuming below ecological carrying capacity limits; and enabling humane, orderly depopulation and deindustrialization? I don't know. It depends on many factors.

[44.1] If you are at the wheel of a dinghy or small boat with an outboard motor; and you spot an iceberg in your way; you can change direction, almost at the last second; and miss the iceberg<sup>77</sup>. If you are at the wheel of a large cruise-ship; and your radar informs you of an iceberg ahead; you cannot wait till the last second; you have to change direction miles away; to avoid hitting the iceberg; and may need to be helped by tugboats; pulling and pushing; if there are any available. If you are at the wheel of a nuclear powered aircraft carrier; you need to alter direction from a greater distance than a yacht; even if you have access to technology like reverse thrust propellers.

[44.2] The same principles apply if you are part of the captains – President or Prime Minister and their intelligence agencies – crew driving a ship that is your nation.

- A. *Tribes that can change direction based upon orders:* If your tribe is small and practices village idiot speak; cause none of their members are easily offended; and so orders and/or information can be shared in brutal clarity; they can quickly ascertain what is reality; and 'change direction'. If your tribe is large – for example Chinese Communist Party 88 million members – but culturally, ideologically and racially cohesive; a small group of politburo members can agree to change its direction; as if it is a dinghy.

## SUMMARY OF NEGOTIATIONS SINCE 19 JANUARY 2016 FILING:

[50] **Unashamedly Ethical:**

[50.1] Excerpts of correspondence with Unashamedly Ethical [Annex A.12, 13<sup>99</sup>; B.01-04<sup>100</sup>].

[50.2] While Lara and Clive were drawing up their Taaibos Barter Exchange Agreement; one of Clive's stipulations was 'Unashamedly Ethical and Family Policy Institute'. Lara did not understand what he meant; so he told her to google it. Lara then read up about Unashamedly Ethical policies; and on 26 July 2015; wrote to Unashamedly Ethical Ombudsman, Founder, Executive Committee and International Advisors: *Are Family Policy Institute and Unashamedly Ethical social and resource conflict problem solving ethics founded upon (i) Ecology of Peace factual reality or (ii) Masonic War is Peace flat earth beliefs?* [[PDF](#)<sup>101</sup>]. The request for information was never answered.

[50.3] After the 19 January 2016 filing; Lara suggested to Clive that it may be helpful to contact Unashamedly Ethical again; to find out whether they provide

alternative dispute resolution services. If so; the process would be less formal; and would help Clive to formulate his thoughts and arguments; and to get some feedback on those thoughts from an outside the family arbitrator. Clive agreed.

[50.4] On 22 February 2016; Lara contacted Unashamedly Ethical; enquiring whether they provide alternative dispute resolution services; and again reminding them that there had been no response to the enquiry regarding whether their social and resource conflict problem solving ethics founded upon (i) Ecology of Peace factual reality or (ii) Masonic War is Peace flat earth beliefs?. There was no response.

[50.5] On 28 February 2016; Lara again contacted Unashamedly Ethical to ask Administrator Jaap Le Roux if he intended responding to the question regarding Alternative Dispute Resolution Services.

[50.6] On 28 February 2016; Lara informed Unashamedly Ethical Ombudsman; that Administrator Jaap Le Roux had not responded to her question about alternative dispute resolution services.

[50.7] On 28 February 2016; Lara notified Unashamedly Ethical Ombudsman of her official complaint.

[50.8] On 29 February 2016; Unashamedly Ethical Ombudsman Keith Matthee responded pretending that Lara had not specified the specific clauses of the UE constitution; which had been breached and the details of the breach; and refused to accept the official complaint.

[50.9] On 29 Feb 2016; Lara notified Unashamedly Ethical: Keith Matthee that she was withdrawing the official complaint; and would proceed via court proceedings.

[50.10] On 01 March 2016 Lara suggested in writing to Clive that he contact Unashamedly Ethical and notify them that he was withdrawing from the corporate entity known as Unashamedly Ethical; and that he no longer want to be associated with them; and request that they remove his name from their database. Clive could still abide by his own unashamedly ethical values and oath; but if the ombudsman is not willing to hold the corporate elite of Unashamedly Ethical responsible for behaving ethically; then they are as bad; if not worse; than all of those whom they criticize as 'corrupt'; and 'unethical'. Clive declined to withdraw his oath from Unashamedly Ethical.

[50.11] On 04 March 2016; Applicant informed Capetown; Hong Kong, Dandenong, Kuala Lumpur, Vancouver, Uxbridge & Auckland Police of Notice of Possible Fraudulent practices being practiced by Unashamedly Ethical: Ombudsman: Keith Matthee; Administrator: Jaap Le Roux; Founder: Graham Power; Executive Committee: Ras Myburgh; Edward Beeka; Amanda Buys; Patrick

Kuwana; Chris Lodewyk; Mgayi Bongani; Gert Roberts; Hardus Zevenster; International Advisors: Roy Chen; Dan Daniels; Datuk Edward Ong; Geoff Tunicliffe; Don Simmonds; Phil Warbrick [PDF<sup>102</sup>]. Proof of Service [PDF<sup>103</sup>].

[50.12] Subsequent correspondence to Capetown; Hong Kong, Dandenong, Kuala Lumpur, Vancouver, Uxbridge & Auckland Police; and Hong Kong Secretary for Justice: Rimsky Yuen; and Canada: British Columbia and Ontario Attorney Generals: Suzanne Anton & Madeleine Meilleur; regarding Notice of Unashamedly Ethical Fraud [PDF<sup>104</sup>].

[51] **Karen Marshall:**

[51.1] Summary of correspondence with Karen Marshall [Annex A.15<sup>105</sup>].

[51.2] On 30 March 2016; Lara contacted Karen Marshall regarding: GMC 5048-14: LJohnstone v C Johnstone & ICC: EoP PoW's –v– Nobel Comm & Peace Laureates et al.

[51.3] Lara provided Karen with a background update on events since her former correspondence where she had requested Karen to confirm her verbal legal advice in writing; and also requested Karen to clarify her ‘send Lara to a psychologist’ statements; so that they could be accurately interpreted. Lara asked Karen if she needed more time to go through the documentation provided Karen; Lara would request a postponement. In the absence of Karen providing her written confirmation of her legal advice; or withdrawing it; Lara would request Karen to do so via court proceedings.

[51.4] Karen responded that she had stated in the past that she wanted nothing more to do with this matter. She did not know what this latest communication is about, and did not intend to read it. She requested that Lara cease all further communication with her.

[52] **Clive Johnstone:**

[52.1] Summary of Excerpts of correspondence with Clive Johnstone [Annex A].

[52.2] On 01 April 2016; Lara provided Clive with a copy of correspondence to Frode Moe; regarding the impending ‘financial request for damages’ refilling of GMC 2578-14; which originally simply requested an apology from Frode Moe for his ‘mental disorder’ allegations.

[52.3] The correspondence to Frode also enquired whether Frode's repeated refusal to provide his 'mental disorder' legal definition and support; should be interpreted as the possibility that his 'mental disorder' allegations were a cover for his real covert motives? Was Frode accusing Lara of having a mental disorder for attempting to educate ecologically illiterate Africans about the biological warfare depopulation consequences of ecological illiteracy; via the information disclosed in the military necessity Iatrogenic Origins of AIDS airport bombthreat; because it exposed the covert depopulation forces in western medicine; who would prefer to profit from breeding and culling Africans; rather than simply honourably educating them? If so; was he going to accuse anyone and everyone; including former SA National Defence Force soldiers who have confirmed their knowledge of AIDS as an Iatrogenic depopulation virus – such as J.D Frazer – of having 'mental disorders'?.

[53] The email to Frode and JD Frazer upset JD's wife. JD phoned to complain to Clive about his wife being upset about the email she received from Lara. Clive and Ann were very angry and an angry porch meeting was held; where among others Clive and Ann made mental disorder allegations; and threatened to have Lara institutionalized.

[54] Subsequent to the meeting; Lara emailed Clive and Ann:

If Clive and Ann **are willing** to help Lara with her assisted suicide plans; either (a) financially by making an agreement to provide the Dignitas Die in Dignity funds; or (b) to help Lara to provide Lara with supporting letters confirming Lara's financial status; to help her to file an application for Exemption of Assisted Suicide fees. See email with the subject: *GMC 5048-15: Request Clive and Ann Help for Dignitas Assisted Suicide for Lara.*

If Clive and Ann **are NOT willing** to help Lara with her assisted suicide plans; either (a) financially by making an agreement to provide the Dignitas Die in Dignity funds; or (b) to help Lara to provide Lara with supporting letters confirming Lara's financial status; to help her to file an application for Exemption of Assisted Suicide fees. See email with subject: *GMC 5048-15: Request Written Confirmation of Everything Clive said and meant in 07 November 2015 and 06 April 2016 porch meetings.*

[55] On 07 April 2016; Clive confirmed; by electronic mail; in writing the following verbal statements made in a porch meeting with Lara and Ann on 06 April 2016, as follows: Clive and Ann want to go to court on 19 April 2016; to resolve the issues in dispute between Clive and Lara.

[56] Relief Requested:

[56.1] As noted in Summary of Lara's response to Clive 13 April 2016 Notice to Oppose:

[56.2] Lara suggests that the matter be postponed to provide Clive the opportunity to digest the evidentiary contents of Lara's Response Affidavit; for his further consideration; to provide the court with his responses to Lara's questions and suggestions to the Issues in dispute.

Signed and Sworn to at George, Southern Cape, South Africa, Pale Blue Dot on this the 17<sup>th</sup> April 2016, the Deponent acknowledging that she knows and understands the contents of this Affidavit, and that she has no objection to taking the prescribed oath and that the oath is binding on her conscience.
