Upon entering the George Magistrates Court House outside lobby on 18 April 2016; to go and park and lock my bicycle; before entering the courthouse to file Reply Affidavit of Lara Johnstone with the Clerk of the Court; Clerk of the Court: Sindile MacDonald Nlazi on his way out to lunch; saw me and approached me and informed me that some of the documents filed in the case with my father had been misplaced.
